Paul Farmer, co-founder of Partners In Health, assumed the editorship in 2007. A leading forum of debate on global health and rights concerns, *Health and Human Rights* moved to an open access online publication with Volume 10, Number 1, in 2008. The journal maintains a tradition of critical scholarship and also provides an inclusive forum for action-oriented dialogue among human rights practitioners, with peer-reviewed articles focusing rigorous scholarly analysis on the conceptual foundations and challenges of rights discourse and action in relation to health.

Health and Human Rights welcomes unsolicited manuscripts. Submissions to the Journal should not exceed 7,000 words. Submissions to the Perspectives section should be between 500 and 2000 words.
